

APPLICATION FOR APPROVAL TO CARRY OUT CONTROLLED ACTIVITY



The Department of Infrastructure and Regional Development protects the airspace around leased Federal airports under the *Airports Act 1996* and the *Airports (Protection of Airspace) Regulations 1996*. Any activities that will result in an intrusion of protected airspace are referred to as "Controlled Activities" that must be approved by the relevant airport-operator company. Any proposed activities that penetrate protected airspace must be referred to Airservices Australia and the Civil Aviation Safety Authority for assessment. Any activities for greater than 3 month's duration must be approved by the Department of Infrastructure and Regional Development. Carrying out a controlled activity without approval is an offence under Section 183 of the *Airports Act 1996*, and is punishable by a fine of up to 250 penalty units. It is an offence under Section 185 of the Act to contravene any conditions imposed on an approval. Under Section 186 of the Act it is an offence not to give information to the airport operator that is relevant to a proposed controlled activity.

Applications must be submitted to Jandakot Airport Holdings at least 48 hours prior to the proposed activity date. Applications may take up to 8 weeks to be approved, subject to assessment.
