6.1. Following the last meeting, a meeting was held with Chris Murray (Jandakot Airport ATC Manager), Chris Brando and Steve Klomp to discuss the discrepancy between the flight paths in the submission from the Winthrop Group and Jandakot ATC's presentation. This has been resolved.		
6.2. Chris Brando stated that overall, the situation has improved. He would like to take back to the group what has been discussed and a proposed course of action.		
6.3. One aircraft was noted during an evening for about 2 – 3 hours with the transponder off and operating with no lights.		
6.4. Chris Murray (ATC tower manager) suggested that it was likely an emergency service aircraft, and the transponder would have been on, however they have the capability to not show up on web track.		
6.5. Chirs Brando requested again if a letter can be sent to operators and include fly neighbourly information with a request to provide a response.

<p>Aircservices Australia currently does not have a community engagement representative based in WA. Hannah Johnson joined the meeting via teams.</p> <p>7.1. <p>8. Department of Infrastructure</p>	
<p>8.1. Commonwealth PFAS Investigation</p> <ul style="list-style-type: none"> • Residents will continue to be provided with fresh water until the investigation is complete. • Residents will be provided with the results from their property along with any associated guidance/advice from relevant WA Agencies. • Investigations are currently underway across 16 airport sites, including Jandakot Airport, and all investigations are expected to be complete by June 2027. • Initial fieldworks and sampling at Jandakot Airport were undertaken between December 2024 and February 2025 and results have been provided to residents. • Water Use Surveys were sent in December 2024, and January 2025, to approximately 150 properties not connected to mains water adjacent to Jandakot Airport. • Residential connections to mains water is not in the scope of the PFAS investigation works. • The Department's consultants have been in the field since 21 February 2025 discussing the Water Use Survey (WUS) with residents and, with their consent, taking water, soil, and biota samples from properties. • Following the Detailed Site Investigation and any Human Health and Ecological Risk Assessment, a PFAS Management Plan will be developed setting out appropriate management actions to address identified risks (expected by mid-2026). • Regular updates will continue to be provided via this forum and on the Jandakot investigation webpage on the Department's website.
